

The James Irwin Charter Schools Board Resolutions: October 27, 2020 Resolution to approve the James Irwin Charter School Revised 20-21 Annual Budget.

### Steve Hester reads Resolution 1:

1. Be it resolved that the James Irwin Charter Schools Board of Education in El Paso County approves the October 27, 2020 Revised 20-21 Budget as presented during this board meeting. Accordingly, the board approves the appropriation of \$20,690,498 to support this budget. This budget includes a projected June 30, 2021 Fund Balance of \$13,666,548.

The expense budget is allocated between the James Irwin Schools as follows:

ES: \$4,876,876

MS: **\$4,519,022** 

HS: Operating fund: \$4,455,232; Bldg Fund: \$1,034,130

Total HS: \$5,489,362

JICA: \$2,991,094

PTEC: \$2,814,144
